- D. SLAM held the 1st Annual Food Drive for the month of October. Patrick thanked Katrina Bibbee for all of her hard work on this. SLAM donated a total of 871 items to a food bank. The winning workout group was RockwoodParkway who donated 277 items. They won the traveling trophy and \$200 towards euipment for their group. O'Fallon IL YMCA took second place with 200 items and Saluki Masters Swim Club was third with 166 items.
